



SugarMynt Gallery Artist Consignment Agreement

This Agreement is made as of the date written below by and between SugarMynt Gallery, located at 810 Meridian Ave., South Pasadena, CA 91030, and the undersigned Artist ("Artist"), working as an independent contractor seeking representation of their artwork through consignment

1. Acceptance of Artwork

Gallery agrees to accept, display, and offer for sale artwork consigned by the Artist under the terms of this Agreement. All artworks must be delivered framed and ready to hang, with either a single sawtooth hanger or a hanging wire. The Gallery will not hang pieces that are not prepared with proper hanging hardware. Any and all artwork must be for sale. We do not accept artwork not for sale.

2. Consignment Period

The consignment period begins on the date of: _____ and will end one week after the close of the exhibit on: _____. Any modifications to this timeline must be agreed upon in writing by both parties.

3. Artwork Pricing and Commission

Sale prices will be set by the Artist. The Gallery will retain a commission of 50% of the final retail sale price for all artwork and merchandise sold. This includes original works, prints, and other related items. All displayed artwork must be available for purchase.

4. Payment

The gallery agrees to remit the Artist's share of sales (50%) within 30 days of the close of the exhibit or as soon as reasonably possible.

5. Shipping Responsibilities

The Artist is responsible for the cost of shipping, delivering, and retrieving all artworks to and from the Gallery. For sold works, the Gallery will cover shipping costs to the buyer.

6. Sales and Exclusivity Policy:

Artwork created for or included in a themed SugarMynt exhibit may not be listed or sold elsewhere for the duration of the show. This includes the same originals, prints, or designs

offered through personal websites, Etsy, social media, other galleries, or any other platforms. Older prints carried by SugarMynt that are unrelated to the current exhibit may be sold elsewhere, but the prices must match the gallery's prices and SugarMynt must be notified. Failure to follow this policy may result in removal from the exhibit and exclusion from future SugarMynt exhibitions.

8. Insurance and Liability

While the Gallery will take reasonable care of all artwork, it is not responsible for theft, loss, or damage during transport or exhibition. The Gallery maintains general insurance coverage; however, individual artworks are not separately insured. The Artist is solely responsible for obtaining insurance coverage for their artwork if they choose.

9. Termination of Agreement

This Agreement remains in effect until the end of the consignment period unless terminated earlier by either party with a minimum of 7 days' written notice.

10. Discount

Indicate the maximum discount percentage the Gallery may offer buyers. If you do not authorize a discount, write "N/A." The artist's 50% commission will be based on the authorized discounted price. If "N/A" is written, or if SugarMynt offers a discount greater than the percentage authorized below, the additional discount will be covered by SugarMynt and will not reduce the artist's commission.
